**Penalties (Working without a permit):** Where work for which a permit is required by the City of White Hall, payment of such double fee shall not relieve any person from fully complying with the requirements of the Arkansas Plumbing and Gas Code in the execution of the work nor from any penalties prescribed herein and no additional permits shall be granted until all fees have been paid.
